Purpose

The purpose of this privacy policy (this "Privacy Policy") is to inform users of our Site of the following:

1. The personal data we will collect;
2. Use of collected data;
3. Who has access to the data collected; and
4. The rights of Site users.

This Privacy Policy applies in addition to the terms and conditions of our Site.

GDPR

For users in the European Union, we adhere to the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016, known as the General Data Protection Regulation (the "GDPR"). For users in the United Kingdom, we adhere to the GDPR as enshrined in the Data Protection Act 2018.

We have not appointed a Data Protection Officer as we do not fall within the categories of controllers and processors required to appoint a Data Protection Officer under Article 37 of the GDPR.

Consent

By using our Site users agree that they consent to:

1. The conditions set out in this Privacy Policy.

When the legal basis for us processing your personal data is that you have provided your consent to that processing, you may withdraw your consent at any time. If you withdraw your consent, it will not make processing which we completed before you withdrew your consent unlawful.

Legal Basis for Processing

We collect and process personal data about users in the EU only when we have a legal basis for doing so under Article 6 of the GDPR.

We rely on the following legal bases to collect and process the personal data of users in the EU:

1. Users have provided their consent to the processing of their data for one or more specific purposes;
2. Processing of user personal data is necessary for us or a third party to pursue a legitimate interest. Our legitimate interest is not overridden by the interests or fundamental rights and freedoms of users. Our legitimate interest(s) are: Activities and Tax Exemption Rights of The British Columbia Directorate of Registered Charities;
3. Processing of user personal data is necessary for us to take, at the request of a user, steps before entering a contract or for the performance of a contract to which a user is a party. If a user does not provide the the personal data necessary to perform a contract the consequences are as follows: If a person does not provide their personal information details in a donation, then the donation cannot be completed. If a person deems it necessary to with-hold their personal data and social media details in a forum or post, it will not be obligatory, rather, optional.;
4. Processing of user personal data is necessary for us to comply with a legal obligation. If a user does not provide the the personal data necessary for us to perform a legal obligation the consequences are as follows: Personal Financial Data is necessary for online transactions, but not so much for posts, blogs, forums, and contact transmissions with the Charity Directors.;
5. Processing of user personal data is necessary to protect the life of the user or another natural person; and
6. Processing of user personal data is necessary to a task carried out in the public interest or in the exercise of our official authority.

Personal Data We Collect

We only collect data that helps us achieve the purpose set out in this Privacy Policy. We will not collect any additional data beyond the data listed below without notifying you first.

Data Collected Automatically

When you visit and use our Site, we may automatically collect and store the following information:

1. IP address;
2. Location;
3. Hardware and software details;
4. Clicked links;
5. Content viewed; and
6. Other types of details that are collected, are: Personal or Company Name, Phone Number, Email Address, Billing Address, Home Address, Credit/Debit Card Details, etc..

Data Collected in a Non-Automatic Way

We may also collect the following data when you perform certain functions on our Site:

1. First and last name;
2. Email address;
3. Phone number;
4. Address;
5. Payment information; and
6. Billing Address, Expiry Date of Credit/Debit Card, Credit/Debit Security Encoding Number.

This data may be collected using the following methods:

1. E-Commerce.

How We Use Personal Data

Data collected on our Site will only be used for the purposes specified in this Privacy Policy or indicated on the relevant pages of our Site. We will not use your data beyond what we disclose in this Privacy Policy.

The data we collect automatically is used for the following purposes:

1. All Financial Data is sent and stored by the POWR Ecommerce Software of the WIX Business Services.; and
2. All other Personal Details and Forum Account Details are stored and administered by the responsibility of the User and of the Web-Site Administrator to Manage Website Forum Details effectively..

The data we collect when the user performs certain functions may be used for the following purposes:

1. To complete a purchase & sale of products or services.

Who We Share Personal Data With

Employees

We may disclose user data to any member of our organization who reasonably needs access to user data to achieve the purposes set out in this Privacy Policy.

Other Disclosures

We will not sell or share your data with other third parties, except in the following cases:

1. If the law requires it;
2. If it is required for any legal proceeding;
3. To prove or protect our legal rights; and
4. To buyers or potential buyers of this company in the event that we seek to sell the company.

If you follow hyperlinks from our Site to another Site, please note that we are not responsible for and have no control over their privacy policies and practices.

How Long We Store Personal Data

User data will be stored until the purpose the data was collected for has been achieved.

You will be notified if your data is kept for longer than this period.

How We Protect Your Personal Data

The security measure that we take to protect user data, is to provide a User Privacy Policy, a Terms of Use, and the cooperation with certain Law Enforcements to Prosecute any Contraventions of Federal &

Provincial/State Laws.

Moreover, the User is requested to contact the Administrator, Mr. Luis Cruz (Email: luisrossanocruzme.com), to be fully removed from data sources effecting the Online Site. The strongest available browser encryption is used to store all of our data on servers in secure facilities provided by WIX Business Services and the Management of the Organization.

Our directors, users, and administrators are bound by strict confidentiality agreements and any breach of this agreement would result in the immediate removal of a Users Account with the elimination of all their Data/Online Site Digital Footprint. A process of disciplinary action or prosecution against individuals or companies by authorities will be required for full cooperation with the Local, Regional, or Federal Law Enforcement.

Our administrators are in clear and concise agreement with the AML Policies with the International Chamber of Commerce, and in continuous dialogue with the Anti-Fraud Department in Ottawa to populate the Anti-Fraud Depository System. The Anti-Fraud Depository System is made available in the event of a CIPIC record search in apprehensions and investigations of individuals with the RCMP.

If any party interested in violating our Privacy and User Terms to put users, directors, individuals and or Organizations at risk of fraud, harm, extortion, unauthorized selling of personal information, illegal trafficking's, misrepresent of personality or identity theft, or threats of violence will be under immediate investigation, and efficiently prosecuted by the authorities, and are convinced to not do so.
